

“The Joint Fundraising Raffle” Sweepstakes
OFFICIAL RULES

“The Joint Fundraising Raffle” Sweepstakes (the “Sweepstakes”) begins 11/15/10; ends 1/19/11. Unless otherwise specified in this offer, online/telephone (donation) entries must be received by 1/19/11 and mail entries must be received by January 28, 2011. This Sweepstakes may be presented in different creative presentations by different non-for-profit organizations (“Presenting Promoters”). **Sweepstakes is sponsored by Sh’or Yeshuv Institute, 1 Cedar Lawn Avenue, Lawrence, NY 11559.**

1. HOW TO ENTER

(a) Donation Option:

- (i) \$100 donation will receive (1) entry ticket each in the First and Second Prize Drawings.
- (ii) \$180 donation will receive (2) entry tickets each in Grand, First and Second Prize Drawings.
- (iii) \$250 donation will receive (3) entry tickets each in the Grand, First and Second Prize Drawings.
- (iv) \$500 donation will receive (7) entry tickets each in the Grand, First and Second Prize Drawings.

All Tickets must be submitted between 10/15/10 and 1/19/11 according to the instructions that you receive. Indicate your choice of the donation options set forth above and your choice of payment method. Telephone/online donations will be automatically entered in the drawings. Donations made at a live event will receive an entry ticket to be entered in the drawings.

(b) To Enter Without Making a Donation:

Handprint your name, address, day/evening phone number and email address (if available) on a 3”x5” card or on a piece of paper and send to: Joint Fundraising Raffle, 1 Cedar Lawn Avenue, Lawrence, NY 11559. Indicate one option from (i)-(iv) above on the front of your envelope to indicate the drawings you wish to enter. For example, if you write (iv) on the front of your envelope, you will receive seven (7) entries each in all three drawings. If you forget to write an option on the front of your envelope, you will receive the maximum number of seven (7) entries in all three drawings. Your mailed entry must be received by 1/28/11. Limit seven (7) entries per person in each of the three drawings regardless of the method of entry.

2. ELIGIBILITY

The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, residents of Canada and other countries only where offered and permitted by law, who have reached the age of majority in the jurisdiction in which they reside. Sweepstakes is void where prohibited by law.

3. PRIZES

One (1) Grand Prize: Winner will be awarded a \$100,000 cash prize. (Approximate Retail Value (“ARV”): (ARV: \$100,000.00). **One (1) First Prize:** Winner will be awarded \$5,000 cash prize. (ARV: \$5,000.00). **Twenty (20) Second Prizes:** Winners will each be awarded \$250 cash prize (ARV: \$250.00 each). Cash prizes will be awarded in the form of a check. Total approximate retail value of all prizes to be awarded: \$110,000.00 maximum value. All prize values are in US currency.

Except as set forth above, prizes may not be substituted or transferred, except by Sponsor in its sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value. Grand and First Prize winners (if a US resident) will receive a 1099 reflecting the value of their respective prize(s). 4. SELECTION OF WINNERS

Winners will be selected on or about February 2, 2011 in a random drawing from among all eligible entries received. A maximum of 25,000 entries will be accepted. The odds of winning depend on the number of eligible entries received. Decisions of the judges are final. Winners will be notified by email and/or US mail, in the sole discretion of the Sponsor. If a potential winner fails to respond after two notices, his/her prize may be forfeited and an alternate winner may be selected.

If offered in Canada, Canadian winners will be required to answer a mathematical skill testing question as a condition of receiving a prize. Any litigation regarding the conduct and awarding of a prize in this publicity contest by a resident of the province of Quebec may be submitted to the Regie des alcools des courses et des jeux.

5. CONDITIONS OF PARTICIPATION

Grand and First Prize winners may be required to sign and return an Affidavit/Declaration of Eligibility and a Liability and Publicity Release (where legal) within fourteen (14) days of notification.
